End-of-Summer Beach Bash 2012 - Code of Conduct and Consent

The following rules of conduct will help our event go smoothly and ensure the safety of all participants. Please take the time to review the list below with your parents, sign it, and return it to the Youth Ministry Office prior to the date of the event. Remember to also complete and return the permission slip.

- 1. Participation in all group activities is expected. Youth ministry is all about building relationships --so relax, get to know everyone, and have a good time!
- 2. Bring some sort of time-keeping device so you can stick to the schedule of activities. Being late can affect the entire group's ability to participate in planned activities.
- 3. Stay together as a group. If you need to leave the group, notify an adult leader or chaperone FIRST, then take a buddy with you. Never be alone.
- 4. Be respectful of your surroundings. Surroundings include people, property, animals, and motor vehicles. Remember that you are representing Resurrection Parish -- a Catholic community. When in doubt, "Treat others the way you want to be treated."
- 5. Do not invite strangers to join our group. Friends are permitted assuming they've filled out the appropriate paperwork ahead of time.
- 6. Public displays of affection (PDA) are not allowed. Only hugging and holding hands are considered appropriate.
- 7. Always carry emergency phone numbers and phone numbers of the adult leaders and/or chaperones. Also carry the phone number of one friend in the large group.
- 8. No possession or use of alcohol, drugs, or tobacco. Violation of this rule will result in an immediate phone call to a parent to arrange a ride home.
- 9. No fighting, weapons, fireworks, lighters, or explosives. Any items found during the event will be returned to a parent at the conclusion of the event.
- 10. No offensive or immodest clothing.
- 11. Minors under 18 years old are not allowed to drive any motor vehicle at any time during the event.

I have read and understood this consent form and I agree to abide by the rules above. I also understand that failure to comply will result in a warning the first time, a conference with all the leaders/chaperones and possible separation from the group the second time, and a call to a parent to arrange a ride home immediately the third time.
